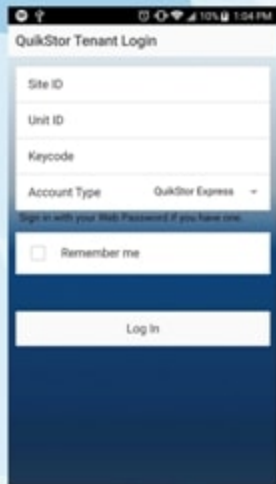

# How Our Tenant App Works

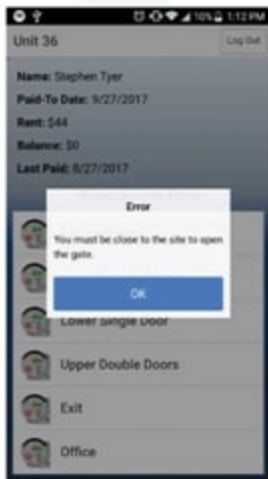


Tenants login to the app using your facilities unique site ID and their unit # and keycode.



Once logged in, tenants can see basic information about their rental. The keypad list allows them to quickly select the access point they need to open.

The Tenant App uses GeoFence technology to ensure your facilities security. Tenants must be close to the facility to open the gate.



# Terms and Conditions

The BUYER enters into a monthly subscription service for the software and services listed in the above contract. SELLER agrees to provide all described software & services to BUYER on a monthly basis for as long as the BUYER remains in good standing with the SELLER and maintains their account as current.

The SELLER has the right to terminate all software access and services if payments are not made in a timely fashion as agreed in this contract. Either the BUYER or the SELLER may cancel this contract at any time by providing a written letter of intent to cancel with a minimum of thirty (30) days' notice. The BUYER agrees to provide the SELLER with a valid ACH account and be setup on an auto-billing monthly payment cycle. BUYERS bank account will be charged the agreed upon amount on the first of every month. If the payment is declined, then SELLER will notify BUYER of this. BUYER will have ten (10) days after such notification to provide SELLER with a valid ACH account to charge. If BUYER fails to do this after this ten-day notification period, SELLER may cancel software access and services at any time.

The BUYER acknowledges that this purchase includes installation support only. The term and type of any further technical support is dependent on the support package purchased.

The BUYER agrees to retain high-speed Internet service (DSL or faster) to each property's management software computer during the duration of the subscription service. Termination of Internet service to the facility management computer may result in an interruption of some services. The BUYER will retain all rights to their property data during and upon termination of this contract.
